Staff update

Evaluation of minor injury and illness clinics and satellite hospitals, December 2024

As part of our ongoing commitment to improving healthcare services Queensland Health will undertake a comprehensive evaluation of satellite hospitals, with a specific focus on minor injury and illness clinics in early 2025. This evaluation will provide valuable insights to identify opportunities for improvement and support organisational learning.

Key areas of focus

- Scope of services available in minor injury and illness clinics
 - Review services offered
 - Ensure services are aligned with community health needs
- Implementation of minor injury and illness clinic models of care
 - Assess the implementation of various models of care
 - Identify variations across facilities and resource gaps
- Workforce assessment
 - Review workforce structures and roles
 - Identify workforce challenges, overtime use, and training needs
- Holistic workplace and security risk assessment
 - Conduct a risk assessment of security and safety measures
 - Ensure compliance with workplace safety regulations
- Funding model evaluation
 - Review current funding model for satellite hospitals
 - Assess how funding impacts workforce and resource allocation

Evaluation methodology

The evaluation will utilise a mixed-methods approach, combining quantitative data analysis with qualitative consultations. This will include document reviews, interviews with key stakeholders, focus groups, and surveys to gather feedback from key stakeholders including staff that work at satellite hospitals.



External consultants

To ensure an independent and objective process is undertaken external consultants will be engaged to conduct the evaluation. The Department of Health's System Planning Branch will oversee the engagement.

How to be involved

In early 2025, consultation across Queensland's satellite hospitals will commence. Staff members may be approached directly to participate in interviews, focus groups, or surveys as part of the evaluation process. Your feedback will be crucial in helping us understand the strengths, challenges, and areas for improvement within the service models.
