

## AMACDT and Medical College Trainee Representatives Discuss Trainee Involvement in College Governance

## 12 December 2024

The third AMA Trainee Forum of the year was held on Thursday 12 December 2024. Chair of the AMA Council of Doctors in Training (CDT), Dr Sanjay Hettige, facilitated a discussion on trainee involvement in college governance with trainee representatives and trainee chairs from specialist medical colleges attending.

## **Reflections and Discussion**

The importance of genuine and well-supported representation on committees and boards was highlighted and shared amongst members. Participants discussed how their colleges facilitate trainee involvement in governance practices, including the extent to which trainees are represented and involved in college committees/boards, and support provided to trainees involved in college governance.

Noting that broad distinctions exist between colleges, trainees agree that strong trainee representation improves outcomes for trainees and increases morale amongst doctors in training. Unfortunately, many trainees feel that positive improvements have often occurred in the aftermath of a crisis rather than proactively, despite the clear benefits of increased trainee involvement in college governance. For colleges with many subspecialties, extra complexities arise to ensure that the diversity of perspectives is heard.

### Benefits of increased trainee involvement in decision making and governance

Trainees broadly agreed that trainee involvement in governance leads to increased morale and improved outcomes for trainees. Colleges with trainee representation on their boards report better leadership decisions across the college structure, improved communication between trainees and college leadership and increased investment by trainees in college processes. Trainee representatives expressed a strong desire for full voting rights for trainees and trainee representation on the board of directors, with these rights leading to greater engagement by trainees in college processes and outcomes.

## **Diversity of representation**

Diversity of representation, including from trainee membership throughout the college structure and at the Board level, is believed to lead to better leadership decisions and greater engagement from trainees. Equitable membership with other College members, such as fellows, is essential so that trainees have full voting rights and can hold positions on the Board. Trainees report that colleges with robust female representation and diversity tend to have better relationships with their trainees.

# Investment in training and collaboration

Trainees emphasised the importance of appropriate governance training for trainees who sit on college boards. Building strong relationships requires commitment from both trainees and board members. It is also important to ensure that the trainee voice is genuinely considered in decision-making processes, involving true collaboration and consultation from the beginning rather than tokenistic gestures.

## Examples of Positive Initiatives Implemented by Colleges:

- Appointment of trainee representatives on college boards.
- Equitable membership for trainees and fellows, such that full voting rights are provided to trainees.
- Timely, free and accessible governance training for trainees on boards.
- Transparent and accessible information relating to college processes made available to trainees.
- Practical and comprehensive policies and procedures.
- Appointment of independent directors to boards.
- Receptive approach to trainee feedback.
- Diversity of gender and background in college decision making processes.
- Mentoring networks or programs.
