Expedited Specialist pathway monthly report - May 2025

- The new Expedited Specialist pathway monthly report is attached. As of 29 May 2025:
 - 322 internationally qualified specialists have applied for registration in Australia since the pathway opened
 - Of these, 18 applications were for anaesthetics, 271 applications were for general practice, 8 applications were for obstetrics and gynaecology and 25 applications were for psychiatry
 - 150 applicants have been registered 1 anaesthetist, 146 general practitioners and 3 psychiatrists
 - 86% of applicants are from the United Kingdom
 - 123 supervised practice arrangements have been approved. Of this cohort, SIMGs have been registered to work in every state and territory except Tasmania.

- Expedited Specialist pathway is the pathway which enables specialist
 international medical graduates to qualify for specialist registration on the basis
 of holding a qualification that the Board considers to be substantially
 equivalent, or based on similar competencies to an approved qualification for
 the specialty.

- The <u>registration standard</u> has been published on the Medical Board website as has the <u>Ministerial Council directions</u> and approvals.

- The Framework has been in place for several years and we now have an opportunity to consider feedback on what's working well and suggested improvements or updates.

- Ahpra and National Boards have published advance copies of two guidelines related to the regulation of registered health practitioners who perform and advertise non-surgical cosmetic procedures.
- The guidelines are:
 - Guidelines for registered health practitioners who perform non-surgical cosmetic procedures (shared practice guidelines)
 - Guidelines for advertising higher risk non-surgical cosmetic procedures (advertising guidelines).
- The Guidelines for registered health practitioners who perform non-surgical
 cosmetic procedures (shared practice guidelines) and the Guidelines for
 advertising higher -risk non-surgical cosmetic procedures (advertising
 guidelines) build on existing responsibilities for practitioners under the codes of
 conduct, the existing Guidelines for advertising a regulated health service and

- other requirements for practitioners who work in the cosmetic procedure industry.
- The guidelines only apply if practitioners in a profession are undertaking cosmetic procedures or are advertising higher-risk cosmetic procedures. While the guidelines may currently be relevant only to a small number of professions, the Boards are aware that the cosmetic procedure industry is consistently changing and internationally the range of professions involved in this practice is expanding. In adopting the guidelines now, we are taking action to future proof the guidelines and protect the public by making Boards' expectations clear if a registered health practitioner considers broadening their practice into cosmetic procedures.
- Publishing the advance copies enables time for practitioners, the public and other stakeholders to understand the guidelines prior to them taking effect on Tuesday, 2 September 2025.
