Candidate Statements

Candidates may submit a statement to be included with ballot material. As per rule 76(10)(c)(ii) 'a candidate statement must not exceed 200 words and will include a biography and/or statement in support of their candidature, together with a photograph of the candidate if desired.'

Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm Australian Eastern Standard Time (AEST) on 12/09/2025 can be accepted.

Voting Period

The ballot, if required, will open on 26/09/2025 and close at 10:00am Australian Eastern Daylight Time (AEDT) on 24/10/2025. A postal vote pack will be mailed to eligible voters on 26/09/2025.

Replacement Voter Pack

If the postal vote pack is not received by 06/10/2025 voters may contact the AEC to request a replacement voter pack by calling 03 9285 7111 or by sending email to lEBevents@aec.gov.au. If you are on the roll of voters, a replacement ballot pack will be sent by regular mail.
