### Submission Guidelines

- Abstract length: Maximum 500 words
- Format: Word or PDF, structured with:
  - o Title
  - Background / context
  - o Aim / purpose
  - o Key findings / learnings
  - o Implications and relevance to theme
- **Deadline for submission:** 6pm AEDT, 31 January 2026
- Notification of acceptance: 2 March 2026

# **Presentation Types**

Each abstract session at the conference will be allocated roughly 30 minutes. Submitters may nominate their preferred presentation format.

### a. Oral Presentation

- 12-minute presentation + 3 minutes Q&A.
- The presentation can refer to a poster or an abstract.
- Presenters must be available for the full session to participate in discussion.

### b. Poster Presentation

- Posters provide a visual and interactive format for sharing work.
- Posters should include title, author(s), background, aim, key findings, implications, and conclusions.
- Use visuals, charts, and images to improve clarity and impact.

# **Review Process**

Abstracts will be reviewed by the AMA 2026 National Conference committee or panel, against the following selection criteria:

- Relevance to the conference theme "Leading Change in a Connected World" and selected sub themes (30%)
- Innovation and originality (30%)
- Potential impact on practice, policy, or leadership (30%)
- Clarity and quality of the abstract (10%)

# **Key Dates**

Call for abstracts opens: By 31 October 2025

• **Submission deadline:** 31 January 2026

• Notification of outcome: 2 March 2026

• Conference dates: 28 & 29 August 2026

## Conditions of Submission

- Members submitting an abstract agree to adhere to all submission guidelines, including formatting, length and content structure.
- At least one author must register for and attend the conference to present, should their abstract be accepted.
- All costs associated with preparation, travel and ticket costs are the responsibility of the presenter.
- By submitting an abstract, authors give permission for the AMA to publish the abstract in conference materials (printed and digital).
- If the abstract includes identifiable patient information, you must confirm that written informed consent has been obtained.
