Strategic capability/leadership	Required in all boards	Board members are to have an understanding of, and contribute to, setting company's strategic direction
Audit, accounting and financial management	Required in all boards	Any Board member who are not a GAICD will be funded to attend AICD one day finance for directors course
Legal	A knowledge and understanding of the law and when to seek legal advice is critical for all boards	Board members must be sufficiently informed to identify potential areas of legal risk and liability
