Session 1: Violence and the social costs of alcohol

All Australians, whether drinkers or non-drinkers, are touched in some way by the negative consequences of harmful alcohol consumption. The adverse social effects of alcohol extend beyond the individual drinker, affecting family members (including children), friends and workmates, bystanders, and the police and services that deal with the consequences of harmful drinking. These sessions underscore the need for action on alcohol by highlighting the scope of alcohol's harms to others, with a focus on alcohol-fuelled violence – both street violence and domestic violence. By drawing on the experiences of the police, families of victims, and front-line medical and community service providers, the sessions will consider the key drivers of alcohol-related violence, and how governments, at all levels, and communities can respond to tackle these underlying causes.

Session 2: Culture, sport and alcohol 3:30pm – 5:00pm

This session considers the cultural drivers of heavy alcohol consumption, focusing on the pervasive advertising and sponsorship associated with sporting and cultural events. Alcohol advertising and sponsorship in sport and other settings create a culture where children and adolescents perceive alcohol consumption as a normal everyday part of life. And they see it as something associated with sporting success or, indeed, being Australian. Strategies to break the nexus between sport, culture and heavy drinking will be considered, including sporting codes that have successfully refused alcohol sponsorship, and options for reducing the exposure of young people to alcohol advertising.

FASD is a devastating but entirely preventable condition that warrants a comprehensive policy response. Australia lags behind other countries in its response to FASD, and over the last three decades there has been little action in its prevention, diagnosis and early intervention or management. The National Action Plan on FASD was released by the Commonwealth in 2013. Securing a commitment to implementing and appropriately resourcing this plan is a policy priority requiring commitments from both the Australian and State/Territory Governments.
